

# Veterans Administration Community Care Program

Veterans can qualify to receive 20 hours of in home non-medical aide care per week – via the Veteran Administration Community Care Network Program.

## CARING FOR A LOVED ONE?

Are you struggling to balance your life and take care of a Veteran family member? The VA Home Care Aide Program provides aide care services to Veterans of all ages who need non-medical care/ assistance to help them with activities of daily living (bathing, grooming, transportation, meal preparation, etc.) to stay independent at home or chosen place of residence.

### VA Home Care Aide Program Qualifications

- ✓ Must be a Veteran (of any age) who served as Active Duty Military.
- ✓ The VA Home Care Aide Program requires a Veteran to need assistance with two activities of daily living (ADLs) if they are over 75 years old. Assistance with three ADLs is required for those under 75.
- ✓ No income or asset restrictions.
- ✓ No VA Disability Rating required.
- ✓ No time of war service required.
- ✓ Can combine with any other VA payments i.e. VA Aid and Attendance or VA Disability.
- ✓ Must have VA Healthcare.
- ✓ Veteran approval for the program can occur in as little as 1 week – depending on the Veteran's situation and the local VA Healthcare System. Average time is 3-4 weeks.
- ✓ The care services must be provided by a VA approved home care agency.

### Our Services

- ✓ Our trusted partner provides a no-cost turn-key service to help Veterans navigate the steps to successfully get access to this VA healthcare aide program.
- ✓ Our partner is a VA approved home care provider in all 50 states via corporate owned locations and 950+ contracted "In network" home care providers.
- ✓ Our partner allows the Veteran the option to have their non-spouse family member or friend be the caregiver. They will appropriately train and hire the family member/ friend as an employee and pay them \$13- \$20/hour to provide the aide care to the Veteran.



## HOW IS THIS DIFFERENT TO THE PCAFC PROGRAM?

- ✓ The Program of Comprehensive Care & Assistance via Family Caregiver (PCAFC) requires a Veteran have a 70% VA Disability Rating.
- ✓ PCAFC requires an extensive application process that can take many months to get approval.

### How Is This Different To The VA Aid & Attendance Program?

- ✓ VA Aid & Attendance (A&A) requirements are more stringent for the Veteran. i.e. The Veteran requires war time service and income/asset limits apply.
- ✓ A&A requires the benefit recipient to spend their income on care to get approved for the maximum monthly benefit.
- ✓ A&A requires an extensive application process that usually takes months to get approval.
- ✓ The VA Home Care Aide Program does not stop the Veteran getting their Disability/ Compensation or A&A payments – they can have both at the same time.
